

Annual Congregational Meeting – Immanuel Lutheran Church In Person/Zoom November 12, 2023

10:45 Call to Order

President Kathy McEnelly called the meeting to order at 10:50. Steve Olmstead offered the opening prayer. Hard copies of the ILC Congregational Report for the year were available to members both in attendance and online prior to the meeting.

Following a motion by Daryl Krieger and a second by Natalie Alsop, the meeting was opened. Following a motion by Ruth Melby and a second by Keith Walker, the Minutes from the 2023 Annual Meeting was approved.

Kathy McEnelly gave the President's Report. She reported on the efforts of the congregation for making the garage sale a success. She also spoke of Intern Elizabeth, praising her efforts and thanks for staying with us during Pastor Rod's Sabbatical, and to celebrate Immanuel's relationship with Bethany as well as sharing our building with Four Oaks, giving us the opportunity to assist in giving students a safe learning space. She also expressed thanks for helping with the Trick or Treat evening by donating candy and helping. She thanked the council members for giving of their time and energy in the mission of the church.

Ellen Olson and Jan Buffington are leaving the council. Thanks to both for their service over the year.

New Council member is Carter Benson. Steve Westerberg will serve as Vice President. Ben Arentson will be the Secretary. Treasurer will remain Jen Jenkins.

This ballot is brought as a motion from the Council. A motion to approve was brought by Kay Sorenson with a 2nd by Joan Beebe. Motion carried.

Presentation of the Budget

Jen Jenkins gave a brief overview of the budget August through September, since we are meeting before the end of the year.

The Budget comes as a motion from the Council. Bob Alsop questioned where the Endowment monies were given. Linda Holland second. Motion Carried.

Pastors Reports

Pastor Rod encouraged all to read his report. He thanked the congregation for supporting him in his ministry. Encouraged all to assist Pastor Zech in his absence during Sabbatical. Glad to see the youth now represented on the Council with the addition of Carter Benson. Stability is so important for smaller congregations and encouraged all to pray for and encourage those struggling congregations. He expressed thanks and gratitude for support.

Pastor Zech reported on the year's program. Carter Benson and Luke Raulie are leading the youth ministry currently. Moving in a positive direction. New Orleans is the location of the Youth Gathering this coming summer. He thanked the congregation for their support.

Kathy opened the floor for questions. Steve Westerberg spoke about the beginning of Small Group ministries, asking the congregation to consider being a part of this ministry. There are a variety of groups available.

Bob Alsop and Ben Arentson moved and seconded the motion to adjourn. Motion Carried. Meeting Adjourned at 11:25.

Special Congregational Meeting – Immanuel Lutheran Church Oct 23 and 27, 2024

Congregational President Kathy McEnelly opened the special meeting at 7:13 pm on October 23. The meeting was called for the purpose of extending a call to Reverent Jeniffer Tillman to the open call shared by Waldorf University and Immanuel.

Pastor Rod Hopp presented Reverend Tillman to those present, reviewing her background and ministry history. He also reviewed the job description for the call. Those present heard from Steve Smith from Waldorf University and from Danielle Niess, member of the call committee.

President McEnelly offered the following motion to the congregation from the congregation council: Whereas, the Immanuel church council, upon receiving a unanimous recommendation from the call committee, voted unanimously to accept this recommendation and send Pastor Tillman's name to the congregation for call. Therefore, Immanuel's Council moves that Immanuel Lutheran congregation call Reverand Jeniffer Tillman to the shared pastoral position for two-thirds time campus ministry at Waldorf University, and one-third time middle and high school ministry at Immanuel. This motion was seconded by Melanie Slater. A ballot vote was taken.

Pastor Rod Hopp reviewed the proposed compensation package for Reverent Tillman. President McEnelly offered the following motion to the congregation from the congregation council: Immanuel Church Council moves that the 2025 yearly compensation package with a defined compensation of \$64,738 and total compensation of \$80,405 with Waldorf to pay 66.65 percent and Immanuel to pay 33.35 percent. The motion was seconded by Mark Jenkins and a ballot vote was taken.

The meeting was then suspended at 7:37 pm until after the worship service on October 27.

Congregational President Kathy McEnelly re-opened the special meeting at 10:33 am on October 27.

Pastor Rod Hopp presented Reverend Tillman to those present, reviewing her background and ministry history. He also reviewed the job description for the call. The first motion was again offered by President McEnelly with a second from Carolyn Price. Those present heard from Bob Alsop from Waldorf University and from Danielle Niess, member of the call committee. A ballot vote was taken.

Pastor Rod Hopp reviewed the proposed compensation package for Reverend Tillman. The second motion was again offered by President McEnelly with a second from Ruth Melby. A ballot vote was taken.

The October 27 meeting adjourned at 10:54 am.

Following the motion, the ballot results were as follows:

Motion #1, the call: 78 yes, 2 no, 1 abstain. Motion passed.

Motion #2, compensation package: 78 yes, 3 no. Motion passed.

Pastor Hopp's Annual Report - February 2025

To the Immanuel Family,

The year past and the year fore merge together in this moment of time. Blessings abound from 2024, worthy of celebration and thanksgiving to our gracious God. There are also issues that cause concern and are worth keeping a watchful eye on as we proceed forward.

February 12, 2024 was the date on which I returned to the office after a twelve week Sabbatical. I've said it before, and I'll say it again, THANK YOU for the gift of sabbatical. It was a time of travel (Germany), learning, rest, reading, disengagement, and re-engagement. Personally, Renae and I were blessed in November with the birth of baby Meredith, our tenth grandchild.

You may remember that while on Sabbatical I discerned that God is calling me to focus on that which may seem small and insignificant in and to the world but that offers a life-giving impact on the lives of people through the word of God.

Because of this I find joy in leading worship and presiding at Baptisms and Holy Communion. I enjoy working with our Middle School youth, caring for them and getting to know them while striving to help them grow in faith love and obedience to God's word. I enjoy responding to those hospitalized, those in times of loss and grief. I continue to believe that our sharing agreement with Bethany serves the small church and impacts the community in Thompson in a big way. The community of Thompson needs that congregation. This is missional work.

We, as a congregation, have a call and passion to serve, and support missionaries and therefore we continued throughout the year to support Missionary Karen in her work among the poor and disenfranchised in Santiago Chile. We also engaged with Waldorf University to form a call committee and have recently called a shared pastor as a missionary to Waldorf students and to middle school and high school students of Forest City. The world neither notices if we do or if we don't do this work, but I believe God notices and says, "well done." It feels good, right, and faithful as we wait upon the Lord.

Our Children's ministry continues strong with Promiseland and VBS programs led and coordinated by Elizabeth Bohl. Pastor Zech strives to enhance online connection to people with God in the electronic/technology sector. Jaci keeps our office functioning efficiently as bulletins and newsletters are coordinated and printed and communication is dispersed. Kim keeps our bills paid, and manages our finances, through the thick and the thin. Geno coordinates musicians and other worship leaders to lead worship and praise to God. Kathy keeps us fed with a plethora of volunteers and delicious menus. Tim keeps the mechanics of the facility operating and functioning properly, and our custodians keep things clean.

Camp participation was strong this year with middle school students who attended confirmation camp and were blessed by their Bible camp experiences. Our relationship with Four Oaks School continues to be a good one. We are making space for kids, as their teachers give these students

a second or third chance to succeed. This is grace happening in our building for students who may otherwise be overlooked. We continue to feed people in multiple ways through our Wednesday evening meals, through our work with the foodbank and the Thanksgiving meal; through the backpack program for the Four Oaks students, and our noisy offerings for ELCA World Hunger and more.

In the coming year I hope we can fill our very part-time Parish Nurse program as it will be one more way we can minister to our seniors, to children and families, to those shut-in, and to other who need healing and blessing. This is Jesus' work, and I believe it will bear fruit for the kingdom of God. I am also hopeful that the small group initiative started in 2024 can take root and begin to expand inviting and enveloping more people into discipleship groups to share life with one another. Council continues to seek ways to help Immanuel grow in our welcome and hospitality to sinners and the world around us, and to help this congregation become more and more "the body of Christ" here and now.

I am truly blessed and grateful to be able to work with the staff we have at Immanuel. Each staff member is dedicated to the ministry they have been called to do, and they are faithful, always doing their best to serve others and bring glory to God's holy name. We, the staff are truly blessed to work with you the leaders and disciples in this congregation to advance the ministry of Jesus here in this time and place. We are blessed by the generosity of you who steward the gifts of God and share your financial resources, spiritual capacities, your often limited time, and your abundant talent for the upbuilding of Christ's church and her mission.

I thank my fabulous wife, Renae, for her continued support. I thank each and every one of you for sharing of yourself, for your growth, for your positive contributions, for all you are and all you do.

So, what happened in 2024? Well, a lot. I continue to be involved with worship, preaching, visiting, Pastoral Care, Promiseland, Middle School, text study, High School, Synod events and other aspects of ministry. Here are some highlights from those areas in the past year. This past year I also took on a little more leadership when Pastor Rod was on Sabbatical. It was a great leading and learning experience working with so many committees, groups, seasons, and individuals that I may not get to on a regular basis. I know I appreciated your support during that time. Things went really well, and the seasons of Advent and Lent were fun to work with Intern Elizabeth. Middle School Ministry was led by Pastor Rod, Intern Elizabeth, and myself again this year at different times. It was a joy talking about topics like Service and music. We got out and did some service cleaning up trash and helping with Wednesday night meals. And when we talked about singing, we had some come in and share how God works through music and even went caroling which was a blast for all involved. I am pleased with the adult involvement once again this year, having multiple adult leaders at different times, ranging from parents to older congregational members. I also want to thank the group helping plan activities for Middle Schoolers, it's been great to have so many different opportunities for the youth. One of the favorites this past year was the laser tag night at church, and I know they're excited about the upcoming lock-in. These Middle Schoolers continue to amaze me. I continue to work with the High Schoolers and they continue to be a wonderful group to work with. Carter Benson and Luke Raulie continue to help guide the group and they also had a blast at the National Youth Gathering this past Summer. The group goes over various topics and Bible devotions which they take turns sharing, and of course game time! I am excited to see this group continue to grow, and the new addition of Pastor Jeniffer will help them expand even more. I continue to be the supervisor for Elizabeth Bohl and work with her on Promiseland. She continues to do a very good job and the program continues to grow and experiment in different ways. In VBS it's been awesome meeting in the afternoons and offering a meal after for families. The meals are well received and is a great way to expand the community around Immanuel. Sunday and Wednesday Night worship have been going well. I enjoy sharing the good news with you all while preaching and leading worship. This past year I had more opportunities to plan worship and experiment with the various seasons. I continue to appreciate getting to know Bethany Lutheran Church and everyone there. And it's been a blast with the four Confirmation youth there too.

Onto the Immanuel Inter-Linked Community. It has been another wonderful year of growth and challenges. The worship tech team has worked hard once again, and I appreciate each and every one that helps out throughout the year. There is still a constant presence of members and nonmembers who are unable to be in the physical sanctuary but are worshiping inter-linked at home. We average about 19 live screens on Sundays and if you figure at minimum 2 people per screen that's 38 people worshipping interlinked at 9:15am. Some services are bigger than others, funerals, bigger Sundays, and weather-related Sundays do have a bigger bump. It's good to know that this resource is being used by so many people still today. The Annual Meeting continues to be inter-linked as do some meetings, the website is visited by those looking for basic information, the service, and the weekly bulletin. Speaking of the website, it did have an upgrade this year so you should take a look at it and see what's changed. Once again, we had multiple online Bible studies on Facebook. There were 28 who participated this Summer and 37 who participated in a Lenten study. Both were well used and received by all those who participated and the participation was consistent and life giving to everyone. This past Advent we also had the Advent calendar once again, and the participation raged from youth groups to the library and many other groups in between. On Facebook we continue to work on telling our story, and there are videos and shorts throughout the year that show who we are and what we are up to along with some photos and big updates. The best received posts are the posts that share the stories of Immanuel. We did have to lose the Remind App this year as they no longer support texting if you're not a school. It's a joy to keep working in this realm with all of you and share the Gospel in many ways. As always if you have questions, or feedback, please contact me, I'd love to hear from you about how things are going.

So, what does 2025 have in store. My role will change slightly with Pastor Jeniffer joining the staff and taking on more of the Middle School and High School responsibilities. I look forward to seeing the youth continue to grow and am excited for what Pastor Jeniffer will add to the team. I'll be able to spend some more time as the Hybrid Pastor and have some more time to make visits. We do have an intern from Waldorf this Winter named Prosper. He'll be working on Electronic Media at Immanuel, so working on the live stream, helping create a couple videos and helping the tech team grow as he grows. This is an exciting opportunity and be sure to say hi to him in the booth if you see him. This summer I will be taking a Sabbatical; the dates are not yet finalized but it will be sometime in May-sometime in August. I'll be getting away for a while and doing some continuing education around Church administration and leadership. I know Immanuel will be in good hands and am excited for the opportunity to keep learning and growing.

I am always grateful and thankful for being inter-linked with you and being inter-linked together with Christ. I look forward to what God has in store for us next at Immanuel and I look forward to continuing working with all of you! Board of Parish Life Annual Report 2024

The Board of Parish Life members for 2024 were Kathy Leuwerke, Linda Ferjak, Mary Kingland, Sandy Lilliquist, Melanie Westerberg, Tina Berg, Lisa Chisholm, Karen Keller, and Pastor Zech.

The Board of Parish Life strives to offer a ministry of hospitality to the congregation and an outreach to the community. The Board also oversees multiple areas of the worship service which includes communion servers, altar guild, ushers, and music and worship. The Vital Agers group is not active right now, but they are still listed under our committee.

May Baskets were filled by the Board and handed out after church April 28th and the Wednesday night service on May 1st. In April, the Board sponsored a Sunday Brunch Potlyck. and on May 5th hosted a New Member Welcome Coffee following church with some help from the Promiseland kids. Later in May, some members helped serve at the Promiseland Picnic which was hosted by the Board of Education. The Summer Picnic which was held on July 14th after the Outdoor Worship Service at Waldorf Pond was well attended. Brian Keely furnished pulled pork, buns, and lemonade, and the congregation was asked to bring individual bags of chips and cookies. The next big event hosted by the Board of Parish Life was the Waldorf Block Party, held on August 20th, to welcome students back for the fall. For Brian Keely provided meat for Walking Tacos, Mary Kingland had 4 cases of Dorito nags, and other members furnished the other things necessary for the tacos. We all brought cookies and asked the congregation to provide cookies also. October brought Waldorf Homecoming. Board of Parish Life put together cards which included a note from Pastor Zech and a coupon for an Ice Cream Cone from A&W for \$1.00. The cards were handed out to the Waldorf Choir, Alumni, and students after the church service on October 20th. In December the Board filled Christmas gift bags to be given out at both services on Christmas Eve. Lisa Chisholm and her husband, John, received grants from Thrivent to help offset the costs for this, the Congregational Picnic and the Block Party. The Board thanks Lisa for this and for being the Board of Parish Life representative on Church Council this past year. Thank you to Tina Berg who is now representing our Board on Council in 2025. We would also like to thank Kathy Leuwerke for putting the budget together for our Board. The Board also provides gifts for visitors. For the spring/summer gift it is a small pot with a packet of flower seeds and in fall/winter we switch to a mug with a packet of hot chocolate, Hershey Kisses and a small flashlight.

Board of Trustees

The Board of Trustees was comprised of the following members in 2024: Pastor Rod Hopp, Tim Severson, Bink Keller, Mike Korth, Kristene Petersen, Kim Severson, Laura Winter, Kathy McEnelly, and Jen Jenkins.

The Board of Trustees focuses on all areas of finance and budget, property, and personnel.

In the area of finance and budget, the Board reviews monthly financial statements, noting all account balances (income and expenses) and makes recommendations to the Council about variations in budgeted expenditures as well as distribution of income. The Board also consults with the Endowment Committee, particularly regarding funds distributed yearly by the Endowment Committee for Immanuel's use. The annual budget is prepared by a Finance Committee and the Board of Trustees adds input and recommends a final budget to the Council for approval.

At the end of December, our financials were sitting at a negative \$17,149.29. In December of 2023, we were at a positive \$15,244.88 for comparison. In 2024, we did have to borrow \$5,000 from the Contingency fund. We were able to pay that back with the December income.

In the area of Property, the Board reviews needs of the parsonage and the church facility. Tim Severson informs us of repairs and maintenance that he has taken care of and of items that need to be addressed. We also have a committee that was put together to review the needs of the parsonage.

In the area of personnel, the Personnel Committee was represented by Kim Severson. The Personnel Committee oversees staff policies and employment issues. Staff positions and job descriptions are recommended and updated as needed.

Mission & Outreach Board 2024

The focus of the Board of Mission and Outreach is to fulfill the mission and outreach ministry of Immanuel. The 2024 members are Ken Korth, Jaci Thorson, Ben Arentson, Ruth Melby, Ellen Olson, Keith Walker, Ryan Strom, and Elizabeth Carr.

Various monthly mission emphases were designated throughout the year. During the first quarter (January–March), the mission emphasis was Hunger, and the money donated to this mission (\$861.77) was shared with the Forest City Neighborhood Food Bank (\$673.77) and the ELCA's World Hunger fund (\$188.00). We also collected and donated 108 cans to the Food Bank. During the second quarter (April-June), the mission emphasis was Western lowa Synod (\$580.17) and Missionary Karen Anderson was our Lenten commitment, and the money donated (\$1079.00) which includes \$493.00 raised from the Red Geranium fundraiser) was applied to our 2024 covenant commitment. We had a monthly emphasis for May, June, and July, the mission emphasis was Bible Camps, and the money donated to this mission (\$965.66) was shared equally with Ingham/Okoboji Lutheran Bible Camp, Lutheran Lakeside Camp, and Riverside Lutheran Bible Camp and did an Ice Cream Social for Missionary Karen during Puckerbrush (\$344.50). For the months of August-October, the mission emphasis was Missionary Karen, the money donated was (\$2,853.75) and we ended up meeting our \$5000 commitment. For the month of November, the mission emphasis will be the Good Samaritan Fund (\$2,784.18) including \$2,038.75 from the Thanksgiving Dinner, and the mission emphasis for the month of December was Student Lunch Fund (\$1,072.95).

Various kitchen items, blankets, sheets, and winter apparel were donated to meet the needs of the Waldorf University international students as well as clothing and a clothes rack for a new interview closet for all Waldorf students to use. Members of the congregation also supported the summer needs of two international students through donations of food, gift cards, and fellowship. The students have been very appreciative of the congregation's ongoing support.

ELCA Global Missionary Karen Anderson retired from her 42-year-old founding position working with EPES (Popular Education in Health) in Santiago, Chile. She will continue to volunteer on their projects but looking forward to spending time with daughters and granddaughter in Minnesota. Immanuel's relationship and financial commitment with Missionary Karen began in 2019.

Immanuel's companion congregation continues to be a church in a small community in the south of the south of Chile, in Punta Arenas, the Evangelical Lutheran Church of the Magallanes. Even though communication efforts are difficult with language barriers, we continue to pray for the congregation at worship and enjoy seeing their activities and worship celebrations via Facebook. (Iglesia Evangélica Luterana en Magallanes)

Once again, thank you for supporting the efforts of the Board of Mission and Outreach. Your generosity has touched the lives of those both near and far.
